**RE: FEDERATION OF EVANGELICAL AND INDEGENOUS CHRISTIAN CHURCHES OF KENYA
(FEICCK) RESPONSE ON THE SUPREME COURT RULING ON THE RIGHTS OF ASSOCIATION FOR
LGBTQ MOVEMENT IN KENYA.**

On Friday 24th February 2023, the Supreme Court of Kenya ruled in favour of the gay movement in the Nation of Kenya.

We the Federation of Evangelical and Indigenous Christian churches of Kenya (FEICCK) umbrella body wish to state that we strongly disagree with the Supreme Court ruling on the following grounds:

1. The Ruling undermines and threatens religious values of Millions of Kenyans on marriage and family as prescribed in Bible and other religious sacred writings. The family is the basic unit of society and the foundation of our all our cultures. It constitutes the root of every human society. The family is so important that the Bible begins with the creation of the world and the family established by Adam and Eve. From Genesis to Malachi and Matthew to Revelation, God consistently uses the family illustration to describe his relationship with the human race. No human court can negate this.
2. The ruling undermines marriage and the family as defined in Article 45 of the Kenya Constitution 2010.
3. The ruling sets a wrong precedence and creates a framework for promoting deviant and irresponsible sexual behaviour, instead of joining religious institutions in this country to support corrective measures and rehabilitation of those struggling with such challenges.
